Welcome New AAM Directors

The AAM Annual Meeting was held on March 26, 2011 at 8:30 a.m. at the International House Hotel, 221 Camp Street, New Orleans, Louisiana. The following board members were elected and we welcome them to the board of directors.

Below are short biographical sketches of the two new board members:

Dean M. Kilgore obtained a B.A. in government from the University of Texas at Austin in 1971. Following graduation, he attended the University of Texas School of Law, graduating in 1975. After being licensed in Texas, Mr. Kilgore spent twenty years engaged in the practice of civil litigation, first at McGinnis, Lochridge & Kilgore, where he served as a partner and coordinator of the firm's litigation section, and later at Kilgore & Oliver, P.C., as President and a principal shareholder. Kilgore now practices exclusively as a mediator and arbitrator. Mr. Kilgore conducted more than thirty trials (16 jury verdicts) in State and Federal Courts. He is admitted to all Texas courts, the United States District Courts for the Western, Northern and Southern Districts of Texas, the United States Court of Appeals for the Fifth Circuit, and the U.S. Court of Federal Claims. Kilgore began his alternative dispute resolution (ADR) practice in 1990, having received his first training as a mediator through the Travis County Bar Association. Kilgore later received training through the Academy of Attorney-Mediators, and numerous advanced mediation trainings through the Association of Attorney-Mediators (and other organizations). Kilgore has

also trained as an arbitrator through the bar of the Western District of Texas, and with The Arbitration Group. Mr. Kilgore now regularly serves as a mediator and arbitrator for complex matters in litigation, both for court-annexed and voluntary ADR, in State and Federal Courts. Kilgore also is a frequent presenter at CLE events. Substantive areas in Kilgore's mediation and arbitration practices include: Technology and E-commerce disputes, general commercial and business matters; construction litigation, eminent domain, land title and value matters; energy law; general tort, products. medical. professional liability, environmental matters; employment matters; insurance coverage cases; and trust and probate questions. More than 1,200 cases mediated and arbitrated, as a member of the Association of Attorney-Mediators (member since 1995). Kilgore also holds the Credentialed Distinguished Mediator designation from the Texas Mediator Credentialing Association, and is a Charter Member of the Texas Academy of Distinguished Neutrals, and Member of the National Academy of Distinguished Neutrals.

Michael Leech has been an AAM member for five years. He is the co-founder and President of the Illinois Chapter of AAM, which at year-end 2010 had 40 members, all but two of whom were recruited through the Chapter's efforts. organized a two-day bridge and advanced training in October, 2010. He joined four AAM Texas members and DePaul Law School Professor Katheryn Dutenhaver in leading the training, designed to bring Texas-style mediation techniques to Chicago. Under his leadership, the Chapter has conducted a pilot program for mediators with the Circuit Court of Cook County in which those receiving the training were provided an opportunity to conduct pro bono mediations. The Chapter has now launched a new program that will provide referrals of cases to AAM mediators for reasonable, negotiated fees, designed to demonstrate the efficacy of mediation in reducing overcrowded court dockets and expand the use of mandatory mediation in the Cook County Circuit Court. Mike is A.V. rated by Martindale Hubbell and was selected as one of the "Top 100 Illinois Super Lawyers®" for 2011. He has been selected as a "SuperLawyer" and a "Leading Lawyer" each year

since the programs began in Illinois in 2005. He was also listed by Lawdragon.com as one of the "Top 500 Litigators in America" in 2005. In the fall of 2010, he was one of three faculty members training staff mediators at the U.S. Department of Education's Office of Civil Rights and has been a guest speaker for the 40-hour mediation training program of the DePaul Center For Dispute Resolution. Mike was selected as a distinguished fellow by the International Academy of Mediators in 2010. He is an AAA mediation panelist and has been certified by the International Mediation Institute. He has conducted over 200 mediations over the past 13 years, including 60 full days of mediation in 2010. He is also a fellow in the College of Labor & Employment Lawyers and is its liaison to the American Law Institute's Restatement of Employment Law project. His publications include the legal treatise Holloway & Leech, Employment Termination: Rights & Remedies (1985; 2d ed. 1995; Supp. 2002). Mike is a founding member of the National Employment Lawyers Association and of the ABA Labor & Employment Section's Committee on Employee Rights & Responsibilities. He is a former member of the Section Council of the Illinois State Bar Association Committee on Labor & Employment Law. He is a partner in the Chicago-based law firm Hinshaw & Culbertson LLP, where he has worked for the past 33 years with a practice in business litigation and employment litigation--and where he now devotes the majority of his time to conducting mediations. Mike received his B.A. (History) from the University of Virginia in 1973 and his J.D. from the University of Virginia School of Law in 1976.

Suzanne Mann Duvall became a full-time mediator more than 20 years ago. She has mediated more than 2000 cases, trained hundreds of mediators and is a frequent lecturer and panel member for alternative dispute resolution programs nationwide. Suzanne is a faculty member and trainer for numerous dispute resolution and educational organizations, including the Dallas Bar Association, the State Bar of Texas, SMU and Texas Wesleyan Schools of law, Texas Woman's University and Texas A&M University. She has received numerous awards in her distinguished career: First Annual American Arbitration Association Steve Brutsche' Award for Professional Excellence in Dispute Resolution; First Annual Tom Eisner Mediator of the Year Award for service to the courts and citizens of Tarrant County; Association of Attorney Mediators Pro Bono Service Award; Louis Weber Outstanding Mediator of the Year Award, Susanne C. Adams Award for Outstanding Commitment and Dedication to the Mediation Professions, State Bar of Texas Frank G. Evans Award for outstanding leadership in the field of alternative dispute resolution; names "Super Lawyer 2003 - 2010; by Texas Monthly and Law and Politics magazines. She has chaired the Dallas Bar Association ADR section, the ADR Section of the State Bar of Texas and is a past president of the Texas Association of Suzanne is a TMCA Credentialed Mediators. Distinguished Mediator.

William H. Lemons, President-Elect 2011

Bill Lemons is engaged in all aspects of Alternative Dispute Resolution, practicing full-time as Arbitrator and Mediator, and counseling companies and individuals on implementing ADR programs. He is an Arbitrator on the Employment Law, Commercial Dispute and Large Complex Case panels of the American Arbitration Association, and is a member of the Panel of Distinguished Neutrals of CPR (International Institute for Conflict Prevention and Resolution), a panelist of the American Health Lawyers Association ADR Services and a Member (MCIArb) of the Chartered Institute of Arbitrators in London. He maintains an active mediation practice, and is a Qualified Neutral for the United States District Courts for the Western and Southern Districts of Texas. He currently serves as President of the San Antonio/Bexar Chapter of the

Association of Attorney-Mediators and has served as Chair and earlier was Treasurer of the ADR Section of the State Bar of Texas. Bill is a member of the College of the State Bar of Texas, Association of Attorney-Mediators, Texas Association of Mediators, Texas Mediator Credentialing Association, Institute for Responsible Dispute Resolution, and is a Life Fellow of the Texas Bar Foundation. Bill has served as a National Trainer/Facilitator in mediation/arbitration skills for the American Arbitration Association, teaching the 40 hour basic mediation skills course to Alamo Community College District, Southwest Foundation, Coca Cola Enterprises, Inc., Zachry Construction Corporation and He also teaches the AAA course many others. "Arbitration Advocacy," and designs dispute resolution programs. Bill is a permanent neutral for Kraft Foods, Toyota U.S.A., Inc., Neiman Marcus and the Alamo Community College District. He sits as a panel member on the Southwest Airlines Company/TWU Local 555 arbitration board and the Montana Labor Relations Board. Now in his 36th year of practice, Bill was a Shareholder with what is now the Cox Smith Matthews law firm in San Antonio immediately prior to this career, and before that was in house labor counsel for Braniff Airways in Dallas.

Requirements of Professional Liability Insurance

AAM's insurance policy requires that its members provide mediation participants with the following information:

- a written statement to all parties explaining the member's role as a neutral intermediary and stating that the member may not act as an advocate for either party.
- in cases where the member assists in preparing a written settlement agreement in connection with the provision of dispute resolution services, a written statement advising each participant to have the settlement agreement independently reviewed by the participant's counsel before executing the agreement.

A "Notice to Parties in Mediation" can be used by AAM members to send as an enclosure with their initial letter to the parties or handed out at the mediation. Alternatively, the wording of the notice may be incorporated into the initial letter to the parties or the Agreement to Mediate to be signed by the parties. The language regarding drafting the agreement can be incorporated into the agreement, itself. The "Notice to Parties in Mediation" can read as follows:

The mediator acts as a neutral intermediary for the parties. The mediator can not and will not act as an advocate for any of the parties. Additionally, in the event the mediator assists in preparing a written settlement agreement pursuant to a mediation, each participant should have the settlement agreement independently reviewed by the participants counsel before executing the agreement.
