Everyone who comes to a mediation has had something happen in their lives that they did not expect to happen. They have usually hired a lawyer to represent them. I help the clients and the lawyers have conversations they were unable or unwilling to have prior to the mediation. The types of cases include multi-party catastrophic injury cases, complex construction litigation, commercial arguments, wide ranging professional liability disputes, and estate and property disagreements.

After mediating over 4,000 conflicts and trying dozens of jury trials, I have found three qualities often helpful to mediators and clients: they embrace discomfort, they radically listen, and they accept their role, however small or large, in the dispute. As a mediator I want to help people explore possibilities that were difficult to find on their own. Brent served as Counsel to the Speaker of the House of South Carolina, the Honorable Robert J. Sheheen. He then proceeded to clerk for the late Judge Mathew J. Perry, United States District Judge for the District of South Carolina. After completing his clerkship, Brent joined the law firm of Haynsworth, Marian McKay and Gerard (Now Haynsworth Sinkler Boyd) as an associate. Several years after joining Haynsworth, Brent was made a partner at Haynsworth where he served as lead counsel in insurance defense cases, intellectual property cases, discrimination cases, product liability cases, sports apparel cases and appellate cases. Brent was also the lead counsel representing South Carolina governmental entities. From Haynsworth, Brent moved to Womble Carlyle (now Womble Bond Dickinson) as a partner. At Womble, his practice expanded to include the defense of class actions, domestic and international arbitrations, litigation strategies for European based international corporations, and insurance coverage litigation. Brent was part of a distinguished team of attorneys who represented the Honorable James H. Hodges, Governor of South Carolina, in the South Carolina Reapportionment cases based on the United States census of 2000.



Gary Doernhoefer is a graduate of the University of Chicago School of Law, an experienced general counsel, technology entrepreneur and founder of ADR Notable – the leading technology platform designed specifically for dispute resolution professionals. In 2016, discussions with the faculty at the Moritz College of Law at The Ohio State University initially focusing on expanding the use of alternative dispute resolution for a specific industry shifted to investigating how basic technology could assist dispute resolution practitioners generally. By 2019, ADR Notable completed prototype testing of its concept with over 30 mediators, leading to the development of the first comprehensive software platform designed specifically for both individual case and practice management for dispute resolution practitioners. ADR Notable launched commercial operations at the end of 2020.

Angela Downes is a professor at UNT Dallas College of Law in Dallas where she is Assistant Director of Experiential Education. Prof. Downes teaches clinical courses, the 40-hour mediation course, as well as domestic violence and the law: an innovative approach to interpersonal violence. Her scholarship focuses on diversity, cultural responsiveness, and issues of interpersonal violence including domestic violence, human trafficking, and child abuse. She is an active member of number boards and organizations. Prof. Downes was recently appointed by the Texas Governor to serve on the Texas Medical Board. Prof. Downes is also an associate Municipal Judge for the City of Glenn Heights, Texas, and a TMCA Board member.

Kay Elliot is an attorney mediator in Ft. Worth and Dallas, and the coach for the Texas A&M Law School Negotiation, Client Counseling and Representation in Mediation competitions, is a graduate of the University of Oklahoma (J.D. 1964); Southern Methodist University (LL.M. 1984); and the University of Texas at Dallas (M.A., International Business 1990). After five years as an EEOC Hearing Officer, she opened her private practice in 1984 and has mediated and arbitrated over 2500 cases to settlement. She was a founder of the Texas Mediator Trainers Roundtable, served for nine years on the Texas Mediator Credentialing Association board, and is the recipient of the 2018 TMCA Outstanding Credentialed Mediator Award.

She has taught Negotiation, Mediation, Family Mediation, Settlement Advocacy, Advanced ADR, and Client Counseling at Texas A&M (formerly Texas Wesleyan) School of Law for 28 years. Her teams have won regional, national, and international competitions (National ABA Negotiation Champion, International On-Line Negotiation Champion). She is the co-author with Dean Emeritus Frank Elliott of two books: *Simple Dispute Resolution: A Handbook of Settlement Science Solutions* (Knowles, 2008) and the recent edition of the State Bar of Texas Alternative Dispute Resolution Handbook.

Victoria Kumorowski practiced law for fifteen years and earned a Masters Degree of Law in Tax before serving four years as a state trial court judge in Kansas. While serving on the bench, she presided over major civil, criminal, and domestic relations cases. She also earned a Masters Degree in Judicial Studies with a Trial Court Major from the National Judicial College at the University of Nevada at Reno. Although she has maintained her license to practice law in Kansas, Victoria's interest in bioethics later led her to change careers and to become an ordained minister and a board certified chaplain. She earned a Masters in Divinity from Phillips Theological Seminary and a Graduate Certificate in Bioethics from Youngstown State University. She attended courses in Advanced Mediation and in Health Care Dispute Resolution at Capital University School of Law, and a training course in Healthcare Mediation at the University of Pennsylvania. While serving over thirteen years as the director of Spiritual Care and an ethics consultant for a regional healthcare system in Ohio, she wrote a thesis on Bioethics Mediation and earned a Doctor of Ministry in Formational Counseling. Since January 2012, Victoria has taught online courses in Biomedical Ethics, Legal Issues in Healthcare, and Global Issues and Values for Muskingum University in Ohio. Since August 2020, she has also taught Medical Ethics: Decisions Making Under Uncertainty online for Rockhurst University in Kansas City. She recently presented a six-hour CLE on Bioethics Mediation for attorney mediators at Johnson County Community College.

Professor **Homer C. La Rue** has a MA in Industrial & Labor Relations and a JD from Cornell University. He has a BA from Purdue University. He is Professor of Law at the Howard University School of Law in Washington, D.C. He is the founder and co-director of the Howard Law ADR Program. Professor La Rue also is the founder and director of the Law School's ADR Certificate Program. He also directs an ADR externship program for third-year law students with the World Bank Group's Internal Justice System. Professor La Rue has extensive experience as a preeminent and highly sought-after labor and employment law attorney. For more than 35 years, he has served as an arbitrator and a mediator in numerous complex national and global matters, including labor, employment, and commercial disputes. Professor La Rue is President-Elect of the National Academy of Arbitrators, and the recipient of the 2020 D'Almeberte-Raven Award for outstanding service to the ADR field. The Award is the highest honor given by the ABA Section of Dispute Resolution. La Rue is past Chair of the Council of the Section of Dispute Resolution of the American Bar Association. He is the permanent arbitrator for several collective bargaining agreements. Professor La Rue is a member of the labor-management and employment roster of arbitrators of the American Arbitration Association and the Federal Mediation and Conciliation Service. He is a Fellow in the College of Labor & Employment Lawyers. He also is a Distinguished Fellow in the International Academy of Mediators (IAM) and has served on its Board of Governors. The Peggy Browning Fund's 2015 DC Awards Reception recognized Professor La Rue for his fair and impartial work as a labor-management neutral. Professor La Rue was the 2017-18 Neutral-In-Residence at the School of Industrial and Labor Relations (ILR) at Cornell University. He has published several scholarly [articles], including contributing a chapter in "Evolution of a Field: Personal Histories in Conflict Resolution", eds. Welsh and Gadlin (DRI Press, December 1, 2020). One of his current initiatives, known as the Ray Corollary Initiative (RCI), now a non-profit organization, is designed to address the lack of persons of color and women selected as ADR neutrals, particularly in labor-management disputes.

Jeff Kilgore has always been committed to helping others find a resolution to their problems and disputes. His ability to obtain results has been accomplished in his 35+ years in the areas of civil trial law, family law, criminal defense, personal injury law and as a public defender, mediator, volunteer the with C.I. S. Programs in Galveston Schools, HOST programs, debate coach, and served on the committee for a Public Pool in Galveston, Texas. He is father to three children and grandfather to two college age young ladies. He has also worked as a real estate agent, with Federal Reserve Bank and in the construction industry before becoming a lawyer in 1973.
