"Truce or Consequences" is a marvelous theme for AAM's Spring 2019 program in Charleston, SC. Not only a play on words, but a meaningful aphorism. As skilled mediators, the currency we use is information. The more accurate, reliable and truthful the information, the more participants are likely to adjust their positions and compromise where appropriate. Our job is to help litigants understand, objectively and accurately, the consequences of failing to reach a truce. In the process of doing so, however, we remain inherently neutral.

Words do matter. Once spoken or published, they can never be taken back. Sometimes, statements are "walked back," "put into context," "explained" or "softened." As independent facilitators, however, we have the luxury of choosing our words carefully, thoughtfully. We can calibrate the effect of our statements. We work to expose truth, so that the parties can achieve a truce, and avoid the adverse consequences of continued litigation.



ethical dilemmas; and even a "deep dive" by some scuba pros into partnership, probate and family mediation issues.



The Fall CLE in Houston Hit It Out of the Park

Although Friday, September 14, 2018, was a soggy day in Houston, 83 members and non-members braved the weather for a grand slam of a day. We were honored to have **Hon. Josefina Rendón** share her wisdom on cultural matters. The team of **Kay Elliott** (Texas A&M University School of Law) and **Professor Angela Downes** (UNT Dallas College of Law) brought us a multi-faceted topic on knowing your implicit and explicit biases. As mediators, we strive to identify and reduce our biases, improving our emotional intelligence. We were coached by a gifted storyteller, **Joe Bontke** (Deputy District Director, EEOC Houston office), about the generational differences that make a difference in participants' reactions.

Don Philbin, whose amazing data analytics have improved the performance skills of countless mediators and lawyer advocates, gave us tips on reducing the potential for impasse. **Charlie Hanor**, an intellectual property specialist (and adjunct professor at St. Mary's University Law School), presented insights for unique challenges with trademark, patent infringement and other IP mediations. **Chris Nolland**, a perennial favorite lecturer, shared his knowledge on dealing with ethical conundrums. **Jimmy Lawson** (author of *Tales from Uberville*) gave advice on mediating multi-party insurance coverage cases. **Gloria Portela** and **David López** reported on a timely topic dealing with the "Me Too" movement and adapting classic mediation methods for current times.

It was a home run day. Important, timely information was available for all participants to adopt in their own practices. Another AAM program that taught us how to load the bases and avoid errors!





Board Revises Insurance Language

AAM's Board has clarified with revised language that, "**whenever reasonably possible,**" members are required to "acknowledge in writing by counsel for the respective parties" that the mediator is a neutral intermediary and not an advocate for either party. (This can be done easily as part of the sign-in sheet signed by all parties and attorneys before the mediation commences). *This wording will be included on the updated insurance summary which arrives with your membership renewal confirmation email for 2019.
